#### b. Parish Council 125 years (Previous minute 19/172.3)

The minutes of the first Parish Council meeting, held on 4th December 1894, have been forwarded to Councillors. Early years minutes were mainly about allotments, footpaths, and the Public Hall. In 1896 there is the first reference to the Parish Council writing to three residents asking them to repair the road leading to their properties. The cost for repairing the Oscroft Bridge in November 1896 was £2 5s 6d. Interesting to read that on 11th September 1913 a lighting committee was established to enable the village lighting to be switched on by volunteers and in 1919 the Council had a mortgage on the Public Hall.
