15/033.1 New Written Requests for Dispensations

Members were invited to declare any Disclosable Pecuniary or other Interest in any item of business on the agenda and, if necessary, leave the meeting prior to discussion of that item.

Councillor Cotgreave stated that the Clerk was making an appointment for him to obtain advice from the Legal Services and the Monitoring Officer at Cheshire West and Chester Council regarding Minute 15/042. He declared a Close Associate Interest as he thought that was probably the appropriate declaration to make. He added that under the circumstances he would remain in the room but not take any part in the item.

emphasised the importance of the proposed project. She had stated that the amount being requested was £2,625, slightly less than in the letter to Council, as their other source of funding had promised a slightly higher figure than anticipated.

Dear Cllr Dixon

School Transport Policy

One of the previous administration's budget cuts was to change secondary school transport arrangements from September 2015. The effect of the change would be to charge Tarvin pupils transferring to Tarporley High School, because Tarporley High School is not the closest secondary school. This is despite the fact that Tarvin Primary School has traditionally been one of the main feeder schools for Tarporley High School, that the three geographically closer secondary schools are all currently at or near capacity and can only be accessed by using the already severely congested A51 between Tarvin and Chester, and that the actual cash saving will be minimal. Tarporley High School also strongly opposed the change of policy. In order to help reduce the cost to Tarvin parents, Tarporley High School has had to divert money from its budget for teaching and learning, something which the Parish Council deplores.

In the circumstances the Parish Council hopes that you will review the policy change as a matter of urgency and reverse it. Such a reversal would cost very little money, particularly in the current financial year, as the Council has agreed to provide a £25,000 mitigation fund for two years to reduce the immediate impact of the change of policy. Instead, the £25,000 can be used to meet any additional transport costs, if in fact there are any. Yours sincerely
