6. PLANNING MATTERS

a. **APPLICATIONS**

The following Planning Applications will be examined at the meeting along with any others received up to the day of the meeting providing that the late application does not cover more than one dwelling:

20/00440/FUL - Extension and alteration of existing outbuilding to form residential annexe (Partly in Retrospect) - Smithy Farm Ryecroft Lane Bruen Stapleford

20/00624/OUT – Erection of two office buildings – Apex House, Chester Road, Tarvin The development straddles both Ashton Hayes and Tarvin parishes. As a result both Parish Councils are being consulted. Comments from Ashton are as follows:

"The proposed site lies within the Green Belt and no 'exceptional case' for development has been put forward. The site has previously been used for a reclamation business whose space requirements have reduced over time. We are not aware if the site has been listed as a brownfield site.

The development as proposed is out of character for the location and would be highly visible from the main road increasing the perceived. building density substantially. No additional mitigating screening has been proposed. It is very visible from across the fields to the rear.

The proposed development would create office accommodation for businesses and employees. However there is no evidence of any local demand for such premises, which if it was required could not be satisfied elsewhere. Also there is nothing to suggest that the type of development proposed would benefit local businesses or create local employment opportunities or support the local economy.

Any office development would increase energy consumption for heating, ventilation and office equipment. However nothing has been proposed as to how this might be mitigated. There is a good opportunity (given Ashton Hayes energy reduction ambitions) to aim to make such buildings carbon neutral and hence substantially reduce operating costs as well. There are 2 pollution and sustainabilty concerns to be addressed.

The building designs tend to resemble housing and a concern has been expressed that permissions may be sought to convert these to a different purpose in the future" **20/00639/FUL** - Two storey extension to side, addition of balcony to side elevation and

external alterations – Oscroft Hall, Cross Lanes, Oscroft

20/00687/FUL - Single storey rear and first floor side extension – 11 Heath Drive, Tarvin

A resident living on High Street regularly observes cars leaving the village heading towards the A54 junction at excessive speed completely ignoring the 30mph limit and is asking what can be done to reduce this - for example a speed warning sign

13. CORONA VIRUS

a. Report from Councillor Lush

The Covid19 pandemic is having an impact on our community. Various local initiatives are underway or planned. The ones that are known are set out below.

Snow Angels are able to provide services that includes weekly befriending telephone calls, help with shopping and prescriptions, dog walking, whilst keeping to the social distancing advice. They have also set up several accounts with Morrisons and Tesco for on-line delivery using their bank details and the older person then sends a cheque to cover the shopping. (They have found that for a lot of our more vulnerable clients they do not want to enter their bank details on-line.) However, the waiting time for deliveries is growing, up to ten days for some stores. They are also investigating local shops across Cheshire West to see if they do home deliveries.

In addition Tarvin churches are planning a telephone befriending service that may well get extended to mirror all or some of what Snow Angels offer.

Finally the Chairman of the PC wrote on 9th March, in a personal capacity, to Tarvinonline asking residents to look out for their neighbours particularly those on their own, with a disability or elderly.

These are extraordinary times. In such times residents look to public bodies for authoritative and objective information, for advice, for guidance and for support. What should or could Tarvin Parish Council do?

b. Report from the Clerk

Council needs to be in a position to continue with its work during the coming months. To achieve that much may need to be done differently but within either existing Standing Orders, other Council Resolutions, and Government Legislation and Guidelines. NALC is engaging with Smaller Authorities' Audit Appointments about audit and with the Ministry for Housing Communities and Local Government as a matter of urgency on a range of issues including whether normal Council meetings are able to be held. PROPOSALS:

The Clerk to consult with Councillors as he considers appropriate

- c. that the Annual Parish Meeting scheduled for Saturday 9th May 2020 is cancelled.
- d. In the event that the Clerk is unable to attend work any necessary decisions may be taken by the Advisory Working Party in consultation with all Councillors.
