23/209.1 Planning Applications

24/00013/FUL – The demolition of the existing farmhouse and erection of one new detached dwelling – The Limes, Holme Street, Tarvin

Comment: We object to the proposed demolition of the existing farmhouse. The proposal would result in the complete loss of a building that contributes to the character of the local area, has clear aesthetic value and represents part of Cheshire's agricultural built heritage. We understand that the interior of the property has many high-quality arts and crafts era features; the loss of these features should be taken into consideration when assessing the demolition application.

The farmhouse which is shown on an 1838 tithe map is typical of the farmsteads built during the growth in Cheshire's dairy industry that took place between the 17th and 19th centuries and has vernacular features that add to the distinctiveness of the local area. A sensitive conversion of the building would preserve its communal and historic heritage significance and ensure that these local features and a sense of place are retained.

23/210 KING GEORGE V PLAYING FIELD

The application for funding for the new goals and nets had been forwarded to Cheshire West and Chester Council and a formal response was awaited. Borough Councillor Lush had indicated that he would be increasing the contribution from his budget to £1,200. This would reduce the balance to be paid from the Community Infrastructure Levy to £485.40 providing that Borough Councillor Cooper approved the request for funding from his budget.

23/211 DEFIBRILLATOR

Councillor Ryan reported that:

- O He was waiting for a quotation from a contractor to cover the groundworks, which included the excavation to cast a concrete foundation base on which the steel framed support to the defibrillator cabinet would be mounted together with cable ducting through which the SPN power cable would be threaded.
- A CWAC Highways NRSWA Section 50 Road Opening Licence Application would need to be completed once he had the above quote and the quotation for Traffic Management, was awaited.
- The contractor who will carry out the electrical connection of the SPN supply cable to the Defibrillator cabinet had given him the cost of the necessary weatherproof fittings. The work would be carried out without charge, other than for parts.
- He had a price for the steel frame which would require painting with Hammarite.
- O A piece of 20mm marine plywood, 450 x 480 was required to fix into the support frame, on to which the Defibrillator cabinet would be mounted.
- An APN quotation had expired so it would be necessary to re-apply.

23/212 ROAD SAFETY

Vehicle Activated Signage

The December 2023 meeting had chosen a 450mm diameter roundel rather than the 600mm which had been quoted at the last meeting. The amended reduced quotation for the two signs had amounted to £6,191.36 plus VAT. Installation of the above and Commissioning £750.00 plus VAT. There would also be an additional charge from Highways of approximately £500 plus VAT for their work on installation. Total Cost, approximately £7,441.36 plus VAT.

The order had been placed and the equipment was expected to be ready for installation around the middle of February. Highways had preparation work to complete and they had

been asked to undertake this with a view to installation taking place in the second half of February.

Highways had indicated that if any representations were received from residents associated with glare/the flashing of the device into properties after installation, it would be the responsibility of the Parish Council to fund any changes or its re-location.
