# 23/117.1 New Written Requests for Dispensations

Councillor Lush declared an interest in all CWaC matters that impacted on the Tarvin/Kelsall ward directly, but specifically the Tarvin PC area e.g., proposal to close a road to deal with a pothole or indirectly e.g., a policy that changes how an issue will be dealt with that could have potential implications for the Tarvin PC area. The declaration was made due to his position as a Cheshire West and Chester Councillor. Councillor Lush declared an interest in Planning Application 23/02660/FUL as he knew the applicant. No other declarations were made.

An appeal had been made to the Secretary of State against the decision of Cheshire West and Chester Council to refuse to grant planning permission for the above proposal. The appeal to be determined on the basis of written representations.

# 23/123.4 OTHER

23/01404/S73 - Change of use of existing vehicle workshop to retail associated with the existing petrol filling station and provision of managers flat - Variation of condition 5 (opening hours) of application 21/03484/FUL - Greenacre Garage, Church Street, Tarvin The matter had been reported to Planning Enforcement, but they had yet to allocate it to an officer due to a backlog of work.

**RESOLVED**: that the Clerk report the issues highlighted under minute 23/120.2.2 and 23/120.2.3.

# 23/124 KING GEORGE V PLAYING FIELD

23/124.1 Football Goal Posts (Previous Minute 23/104.1)

Councillor Twigg was waiting to hear the outcome of the request for funding.

23/124.2 Swing in Children's Play Area (Previous Minute 23/104.2)

Wicksteed did not have the necessary part in stock, but they had a used one which was being ordered.

## 23/124.3 Field Management Committee Meeting

The meeting noted that the meeting scheduled for 13th September had been cancelled as only Councillor Twigg and the Clerk were the only two in attendance when the meeting had been due to start.

# 23/124.4 Electric Bikes

A concern had been received regarding electric bikes being used on the field. On Saturday afternoon 9th September at about 3pm there were two electric bikes being raced around the field at a high speed. There were a group of eight young people with two on the bikes.

**RESOLVED**: that the matter be brought to the attention of PCSO Hannath as no bikes should be ridden on the field.

# 23/125 WAR MEMORIAL

#### Brass Plaque Cleaning

Councillors Ryan and Williams had washed the plaques as advised but it had not made a significant difference. A quote of £977.84 plus carriage and VAT had been received to remove and later replace the plaques after being refurbished.

**RESOLVED**: not to accept the quote or look for alternatives.

# 23/126 ROAD SAFETY

#### 23/126.1 Signage

The quotes for the vehicle activated signs for Tarporley Road and Shay Lane had still not been received despite Borough Councillor Cooper being asked to help.

**RESOLVED:** that Cheshire West and Chester Councillor Lush write to the Director of Highways asking for progress with this item.

#### 23/126.2 Lower High Street

The meeting noted that there had been an incident on Lower High Street very early morning 16th September. What appeared to have happened was that the road had been closed due to United Utilities work, and someone had driven a white fiat (SJ59 WWK)

down the street and straight into the road works and then left the scene. The Clerk had **23/126.2.1** informed PCSO Hannath and Highways.

**23/126.2.2** sent detailed responses to two residents, in response to their concerns, informing them of the work that Council and Highways were undertaking.

## 23/127 DEFIBRILLATOR

This item had not been progressed.

**RESOLVED**: that Councillor Ryan check with the Conservation Officer to ascertain whether planning approval was required.

## 23/128 CO-OP CAR PARK

This item had been escalated. The area had been tidied, and the contractor had been instructed to check the wall and if necessary clear up on a regular basis to ensure that the area was safe.

## 23/129 PUBLIC CAR PARK

The Diocese of Chester had said that the position had not changed, they wished to retain the land and with the present usage.

The local resident had kindly agreed to donate a large tree for the village which would be positioned in front of the Methodist Church.

#### 23/131.2 Other Trees

Councillor Ford reported that the trees would be purchased from the same contractor as last year and at a similar cost.

#### 23/131.3 Installation of Trees

**RESOLVED**: to install the trees on Sunday 26th November and not the Saturday as had been previously agreed as the streets should be much quieter.

# 23/132 INSURANCE

Parish Council Insurance was due for renewal on 1st October 2023. An alternate quotation had not been sought as Council had a long-term agreement which was due to expire on 30th September 2024.

**RESOLVED:** that the new premium of £1,943.18 be approved

#### 23/133 REMEMBRANCE SUNDAY

The meeting noted that the Clerk would be ordering the wreath for Council and making the donation of £300.00 (agreed budget figure) during the next few days.

The Churches had indicated that the service on the Sunday would be held outside St Andrews Church but streamed into the Methodist Church for those who preferred to be inside. Councillor Ford confirmed that he was available to represent Council at the service and read "In Flanders Fields".

# 23/134 TARVIN/OSCROFT CLEAN UP

The meeting noted that the next litter pick would start at 9:30am on 21st October and finish no later than 12:30pm. Pickers, bibs and bags could be collected at 9:30am at Tarvin Community Centre for the Tarvin pick or Oscroft Green for the Oscroft pick. **RESOLVED:** that the Clerk order more equipment (but not pickers) from Cheshire West and Chester Council.
