14/150 STREETSCENE/HIGHWAYS

14/150.1 Lower High Street (Previous Minute 14/096.4)

Highways had responded to the request for Unsuitable for HGV signs by stating that they couldn't support the proposal. They had said that "The guidance on Unsuitable for HGV's signs specifies that these will generally be used where there are problems with drivers becoming stuck due to over-reliance on sat-navs, and as such we have only provided them on narrow lanes. We don't consider it appropriate to provide these signs on all the entrances to Tarvin as it could confuse HGV drivers who wish to access to the village to make deliveries etc."

RESOLVED: to accept the report from Highways

14/150.2 Oak Tree Tarporley Road

On 7th May 2014 Highways had been asked to obtain a report on the Oak Tree on Tarporley Road. The report from the Tree Surgeon received on 4th June 2014 had stated that "The tree is in decline with some large dead sections in the upper crown. However the tree is attempting to form a new crown lower in the tree with new growth forming on the stem and lower branches. We would recommend this tree is significant reduced by up to 50% to remove the deadwood and force the tree to retrench. This work should be carried out to ensure a continued contribution by the tree to the environment and to remove the risk of significant dead branch failure." The report had been forwarded to Streetscene who later had informed the Clerk that the work had been completed.

The work had not been carried out and the Clerk had spoken to both Highways and Streetscene who were investigating and had promised a report later in the week.
