**RESOLVED**: (16/066.1.3) not to reconsider a previous proposal for a circular path or track around the whole of the field, which could be used by walkers/runners and by children on bikes. (Previously rejected 27th July 2015).

**RESOLVED**: that the old blue waste bin be removed from the children's play area and not replaced.

### 16/066.3 The George Heath Foundation

The Foundation had booked the field for a football tournament on Saturday 27th May 2017.

**RESOLVED**: that the Clerk write to the Foundation reminding them of the issues raised during and following the event held earlier in the year and requesting that these be given additional consideration when planning next year's event.

The meeting noted that the External Annual Inspection would be taking place during July **16/066.7 Tennis Courts** 

The Clerk reported that the contractor working on the Tennis Courts to install the underground cabling had broken the lock and chain on the gate between the children's play area and back of the court in order to carry out their work. A temporary lock had been put in place by the Tennis Club.

# 16/067 CONSIDERATION OF FEEDBACK FROM GLADMAN FOLLOWING PUBLIC CONSULTATION

A copy of the summary of the feedback received from Gladman following the public consultation is attached to the minutes.

**RESOLVED**: that the following be forwarded to Gladman:

The Parish Council welcomes the opportunity to see the public comments on the Gladman proposal for housing on part of Church Farm and hopes that the following comments are helpful.

First the Council accepts that **IF** there is to be any further substantial housing development in the parish area it should be in Tarvin village and east of Church Street/Tarporley Road is the only realistic location. However, at this stage the Council, noting that Tarvin is likely to meet its Local Plan housing target in 2016, **neither supports nor opposes the Gladman proposal**. The following are therefore detailed observations given without prejudice.

- \* Council accepts the need for more recreation provision in Tarvin village. The Council notes that the first Neighbourhood Plan community questionnaire plus follow- up work suggested an all-weather pitch was needed more than a multi-use games area. **Any** recreation provision should be sited adjacent to the car park, have changing facilities and have facilities for skate boarding.
- \* Council consider it vital that the settlement boundary of Tarvin village should be fixed along the line of the existing public footpath that runs north/south from the rear of the church. It notes that the current Gladman proposal extends marginally east of this line but importantly the area is shown as a green space.
- \* Council is aware that the Neighbourhood Plan Steering Group is currently undertaking a further survey of residents and two of the topics are housing and recreation. Once the results of this survey are available they will help the Council if a planning application comes forward.
- \* Council would like to see the all-weather pitch available to the whole community and therefore the day to day costs met by the whole community, management to be agreed.
- \* Council would like the 30% affordable properties to be a firm commitment
- \* Council considers that the points made regarding the legal agreement to be very important
