The following is a copy of a minute from the May 2018 Council meeting:

"18/043.1 Skate Park - Since the last meeting an e-mail from a resident had been forwarded to Councillors and some thoughts had been shared between Councillors. The Clerk and Councillor Twigg had met with the resident and a second resident had attended. By the end of the meeting the residents accepted that it was unlikely that the present Section 106 money would be spent on a skate park due to the lack of available land and the time limit. The residents were planning to approach land-owners and to advertise the requirement to see whether they could find some land that would be suitable for a skate park at some point in the future."

One of the residents referred to above spoke to the Clerk on 9th October to confirm that the two parents are still very keen for Tarvin to have a Skate Park but they have yet to find appropriate land available in Tarvin. There has been ongoing communication since then.
